First, Education Requirements for LPN/LVN Most state boards require additional education for an LPN/LVN to be able to manage the infusion of patients. This is what IV Mastery provides.

Second, Competency Demonstrations
To become qualified to perform infusion therapy as an LPN/LVN, you must demonstrate your competency by completing a skill check overseen by a facility preceptor.

Third, Scope of Practice

To be allowed to manage infusion therapy on patients, LPNs/LVNs must make sure they are working within the legal scope of practice defined by their State Board of Nursing.

IV Education requirements for RNs the Infusion Nurses Society recommends, due to the lack and/or inconsistency of infusion therapy in basic nursing curricula, that the RN complete an organized educational program on infusion therapy.
